# **News & Developments**

### The Forum's achievements in 2023

The CACoP Forum has covered a lot in 2023, and we have been reflecting on our achievements. Some notable highlights from the year include:

- We reviewed the CACoP document and recommended two new Principles be added (see below). These proposals are current with Ofgem for decision.
- We inputted to RECCo's Open Data and Consumer Consent project, ensuring the input they needed was provided and receiving updates on progress.
- We also engaged with Ofgem when it was initiating its Future System Operator (FSO) Code Change Programme (CCP), inputting on the scope, membership, and timeline of this work before it was formally launched.

We have published a report looking back over all our work from the last year, which you can download from the CACoP website here.

# Proposed updates to the CACoP

In 2023, we reviewed the CACoP document for any updates needed. We put forward two new Principles for inclusion which are currently with the Authority for approval:

- The first of these encourages Code
   Administrators to assess the impacts of a
   Modification on end consumers and on the
   drive for net zero
- The second new principle recognises the support that Code Administrators can provide on the Code Reform and Consolidation work.

We also recommended some general changes to the document to better align wording across the Principles, update the common modifications timeline, and correct other minor errors and inconsistencies.

We submitted our recommendations to Ofgem before Christmas, who will make the final determination on any changes to the CACoP document.

# **MHHS Programme: Code Update**

In line with the MHHS Code Drafting Plan, the Code Workstream has received approvals on multiple tranches of Code Artefact consultation releases.

Since the last MHHS update in September 2023, the following tranches have been approved:

- Tranche 1: Data Services and Metering Services
- · Tranche 2a: Registration
- · Tranche 2b: BSC Central Services
- Tranche 3: Migration, Governance and Qualification

We're expecting an approval decision from the Cross-Code Advisory Group (CCAG) on Tranche 4: Interfaces/Data Specifications and Transition Text in mid-January 2024.

The **Mop Up 1 Industry consultation** closed on **2 January 2024**. The Programme will triage and action comments and update the artefacts for Industry Assurance Review.

#### What's next?

The Balancing & Settlement Code (BSC), Retail Energy Code (REC) and Distribution Connection and Use of System Agreement (DCUSA) Mop Up 2 consultation and Elexon and Connection and Use of System Code (CUSC) Consequential Changes will be issued for consultation on 19 February 2024. This will also include a full and final review of all published Code Artefacts.

A **Final Consistency Check** will be issued for consultation on **14 June 2024** - this isn't to consult on the Code Artefacts again as they will have already had multiple consultations. Instead, the aim of this final check is to:

- Reverse engineer the traceability matrix to track every Code requirement to a Design requirement
- Complete a final consistency check e.g. fix numbering, formatting etc.
- · Confirm that due process has been followed





The Programme would like to thank the 79 attendees from 39 separate organisations who supported the Code meetings and the 92 individuals from organisations who responded to these consultations. This has enabled us to produce 12 new Balancing & Settlement Code Procedures (BSCPs) and update 62 other Code Artefacts. 43% of the BSC has been re-written to accommodate changes needed for MHHS, and published for consultation in just 11 months.

### **Programme Change Freeze**

The Programme has formalised a Change Freeze (Code Freeze) to ensure stability during Programme delivery. Thresholds for change that impact the MHHS Programme will be increased until after Go-Live and, in some cases, until after Migration has been completed.

This has been cascaded via the Programme Steering Group (PSG) to decision groups and where relevant, Working Groups.
